




From FY2012 to FY2019 Lighthouse's Return on Investment was 162%. For every \$1.00 spent by Lighthouse, an additional \$1.62 was generated in economic activity and benefits to youth and families assisted as well as to the State of Ohio's economy.

Paul Haffner President and CEO A single mother and only 21, Anne Marie suddenly didn't have a home for her four young children. She went to an emergency shelter where she was connected with Lighthouse and the KEYS to a Future Without Youth Homelessness program. It wasn't long before Anne Marie began learning how to succeed on her own. Her case manager helped Anne Marie and her children move into a furnished apartment and access the training and resources she needed. Anne Marie began mastering all sorts of life skills. She learned how to keep her kids safe, navigate public transportation, and build strong social skills. Today, Anne Marie and her family are thriving.

Lighthouse is the lead agency of a community effort to end youth homelessness called KEYS to a Future Without Youth Homelessness (KEYS). KEYS is designed to ensure all young people ages 18-24 have access to safe, affordable, and stable housing.





Lexavier never had a stable home. He bounced from house to house until he moved into the Lighthouse Youth Development Center when he was 13 years old. At the residential treatment home for boys, he found the safety and stability he craved. He also found Lighthouse volunteer Ray Compagna. Lexavier asked Ray to be his Big Brother after attending a presentation by Big Brothers Big Sisters. It was the first step in a lifetime relationship. At 18, Lexavier moved into an apartment provided by Lighthouse as part of the Independent Living program. Things didn't go well, and he was evicted. As he floundered, Ray told him he needed to figure out his life. It didn't take long for Lexavier to realize Ray was right. He asked Lighthouse for a second chance and got it. This time, he worked hard, embraced the classes and counseling available, and joined Job Corps. Four years ago, Lexavier enlisted in the Army, and things have gone well. The 24-year-old heavy equipment driver plans to find a way to give back to young people as a way to thank those who helped him. Life appeared bleak when Ben's family kicked him out of the house after he told them he was bisexual. After staying with his boyfriend's family for a few days, the college freshman needed an alternative – and quickly. During his search for help, someone at school recommended Ben call Lighthouse. When he did, he found he was a perfect fit for the Host Home program. The Host Home program matches LGBTQ young adults in need of housing with volunteers who provide short-term housing, food, and guidance as the young person works to achieve their goals. With the support of his host family, Ben worked full time and attended college online. In only nine months, he saved enough money to return to college full time and share an apartment with friends on campus. Ben says he doesn't know where he'd be without his host family, Joanne and Dave. He knows his relationship with them will last a lifetime.



The new Lighthouse Green Learning Center Powered by Groundwork officially opened in May, and it's already having an impact in the community. Groundwork Ohio River Valley began leading programs and projects at the center and nearby Community Garden in Madisonville in May, and over the summer, young people in Lighthouse care participated in many of them. Though COVID-19 caused a few challenges along the way, they accomplished quite a bit, including:

- Planting and managing 25 garden beds.
- Maintaining some fruit trees and perennials.
- Assisting with community projects at Bramble Park and two pocket parks in the neighborhood.


