"In August 2024, I was 17 and facing teen homelessness. I felt I had worn out all of my options. I thought that I would age out of foster care and then fall face first into the world.

When Alan began working with his OhioRISE team at Lighthouse more than a year ago, college and independence felt like distant goals. But today, he's enrolled in school, driving himself to classes and work, and providing transportation for his siblings.

Through consistent connections with his therapist, case manager, and medication providers, he learned to manage anxiety and depression, strengthened his coping skills, and gained confidence. Alan's progress is proof that with support, persistence, and belief in oneself, a bright and independent future is possible.

Doug and Melissa Steimle give children in foster care the care and security they need when it feels like their world is falling apart. The Lighthouse foster parents have welcomed more than 40 children over the past 24 years, and each child became a cherished part of their family. Their journey has also included adopting five children.

Melissa and Doug create a stable and nurturing environment for each child. The Steimle family story is one of warmth, dedication, and joy, built over two decades of parenting with purpose.

While in high school, Kaylee's life felt out of control—frequent suspensions, court referrals, and a growing sense of hopelessness. When the courts connected her to Lighthouse, everything began to change.

Kaylee worked with her case manager and therapist, and soon she felt more capable, optimistic, and ready to tackle challenges. She graduated from high school, got a job, and is now working toward earning a nursing degree to become a pediatric nurse.

"Lighthouse made a huge difference in my life," Kaylee says. "They always wanted the best for me, were there when I needed them, and gave me the tools to succeed."






**Total Service Line Expenses**


